On October 14, 2016 at approximately 1700 hours, I responded to 101 Plaza Real S in reference to a follow-up investigation. I spoke via landline with Leonard Pozner. According to Pozner, he received information from his property manager about Felix Pantaleon trying to get information about him.

Pozner received an email that stated, "Hi, via a private investigator. I have been able to track down an individual by the name "Lenny Pozner." To your Royal Palm Place Apartments, Lenny is an individual who slanders and harasses 100's of people daily. He even exploits their children online, if he can get a hold of their pictures. I need confirmation from you guys, if he is a resident there. To file criminal police reports on him, he moves from apartment to apartment. Do to his cyber trolling, he runs online donation scams to pay for his expenses. He recently hacked into one of my emails and it has been reported to NYPD. We tracked the ip, coming from your location. This is why it's crucial to confirm if he's there or not, to get a warrant to get his exact apartment. If you are not aware about what he does, or he gave you guys a heads up. That people are trying to look for him. You can check out all of his crimes (to me) via this link. It excludes the other countless victims he harasses on a daily basis. "

Pozner requested this information be documented so that he could be in the process of getting a restraining order. No further action taken.
